I understand that the Boys & Girls Club of Menominee has an "Open Door Policy." This means that members are free to enter & leave the Club. It is the responsibility of the parents/guardian to instruct their child as to whether they can leave or not.

I understand that my child cannot leave the Club during operating hours without parent authorization.

I understand that my child can not be left at the Boys & Girls Club earlier than the Club's established hours of operation.

I understand that my child must be picked up at or before closing time. The Boys & Girls Club provides no supervision after closing; Members who are not picked up at the Club at closing are the parent's responsibility. The Boys & Girls Club assumes NO responsibility. Continued problem more than 5 minutes late will be charged \$5 per minute. Payment must be made before members come back.

I understand my child's membership standing is based upon his/her ability to obey the rules of the Club, Its officials and staff members. Members may be suspended or cancelled at any time for misbehavior without a refund.

I hereby consent to the reproduction, publication and use of photographs/video footage and Web sites for advertising and/or publicity purposes as deemed appropriate by the organization.

Absence from school

Club members must attend school on good behavior to be eligible to attend the Club daily. If a child is absent or tardy from the school day they are not allowed to be at the Club that day. If a legal guardian calls for the child explaining the missed class time due to Dr., dentist, funeral or family emergency it will be up to the supervisor in charge to make the decisions for the child to participate in Club activities.

Snow Days

The Club will be open 9:00am-5:30pm. If weather becomes severe and the decision is made to close the club notifications will be made on local radio and facebook.

Cancellation Policy

In the event where severe weather or an emergency occurs and the Club needs to be closed, the decision to close the Club will be made by the Executive Director. Announcements will be made on local radio and facebook.

Unplanned Early Release

Early release due to inclement weather the Club will be open until 5:30pm. However there will not be busing on these early release days.

Transportation

Is available from Marinette and Menominee Schools for \$1/day.

Late Pick Up Policy

All members are required to be picked up no later than the Club posted closing time. If a parent/guardian is late and all attempts to reach emergency contacts have failed, the child/children will be considered abandoned and the local Police Department will be notified. For continued lateness more than 5 minutes guardian of members will be charged \$5 per minute until child is picked up. Payment must be paid before member comes back.

General Rules

Please leave all personal items at home (toys, phones, etc.)

No Hats

No Gum

All coats, bags, etc. must be in coat room.

Please respect all others and their items.

Fighting, stealing, bullying, harassing, disrespecting youth or staff is NOT Allowed at the Club. We expect all youth and adults to respect everyone at the Club.

Check In/Out

All members must be checked out by an adult or have permission to walk home.

Please do not call to have your child get ready to meet you outside.

Supervision Policy

If your child has a disability and/or special needs which require increase supervision, the DAR Boys & Girls Club will strive to provide services through volunteers but reserve the rights to require the guardian to provide such supervision or support at no cost to the DAR Boys & Girls Club and/or reserves the right to limit participation.

Dress Code

Club members are not permitted to wear clothing that is inappropriate for the Club setting. Clothing that displays profanity, violence, is sexually suggestive, is offensive, promotes gang activity, or promotes alcohol, tobacco, or drug uses are not appropriate.

Clothing must cover the torso from above the chest cleave to mid-thigh.

No hats, visors, or other headwear allowed in the building.

Footwear must be worn while at the Club. Closed toe shoes are strongly encouraged to protect feet during activities. Club staff has the right to limit participation in activities and program due to footwear.

Technology & Social Media Policy

I give permission for my child(ren) to utilize the DAR Boys & Girls Club technology program, including but not limited to Club owned devices and equipment, and personal mobile devices.
